**SCHEDULE OF ORGANS OF STATE TO WHICH THE  
PROTECTION OF INFORMATION BILL (PIB) APPLIES**

**Explanatory note**

Clause 3 of the PIB provides that the Bill applies to all organs of state. The PIB defines “organs of state” as:

- a. any organ of state as defined in section 239 of the Constitution, including any public entity defined in section 1 of the Public Finance Management Act, 1999 and section 3 of the Municipal Finance Management Act, 2003; and
- b. any facility or installation declared as a National Key Point in terms of the National Key Points Act, 1980.

The Constitution defines “organ of state” as follows- “organ of state” means-

- a. any department of state or administration in the national, provincial or local sphere of government; or
- b. any other functionary or institution-
  - i. exercising a power or performing a function in terms of the Constitution or a provincial constitution; or
  - ii. exercising a public power or performing a public function in terms of any legislation, but does not include a court or a judicial officer.

According to these definitions, organ of state, refers to all National and Provincial Departments; Municipalities; State-Owned enterprises and Public Entities; and Universities.

Below is a list of organs of state to which the provisions of the PIB apply:
